- Provide material such as brief comments, success stories, and/or photos that can be used in the project newsletters or on the web site;

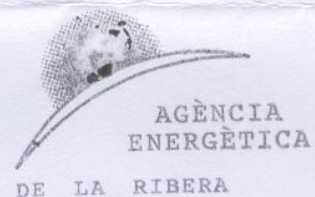
